## Re: Community and Civil Society Consultation on the Global Action Plan for Healthy Lives and Well-Being for All

Dear Sir/Madam,

We appreciate your collective commitment to the Global Action Plan for Healthy Lives and Well-Being for All, and are writing to express our support for your continued efforts. As you know, the Plan is essential for establishing much needed harmony across global health agencies, investments, and programs. We are at a pivotal point in global health, a time at which immediate action is necessary if we are to reach the bold targets contained within SDG 3 by 2030. We hope that through these and other collaborative efforts, global health can finally realize these elusive wins and accelerate progress toward a healthier world in a more inclusive way.

Beyond the work of your respective agencies, it is critical that communities and civil society play a central role in the development and implementation of the Plan, at global and national levels. To date, such engagement has been limited, with inconsistent outreach and inclusion of these stakeholders, notwithstanding attempts by civil society to engage over the past few months. We write to ask that your organizations prioritize conversations with community and civil society representatives, including but not limited to the established Global Action Plan Civil Society Advisory Group. As with any consultation process, this one should be deliberate, transparent and robust enough for external parties to recognize their contributions in the end product and feel their input was valuable.

We acknowledge, with appreciation, the recent consultation hosted by the Global Action Plan secretariat, focusing on Accelerator 3 (Expanding community and civil society engagement). We feel it confirms a need for even greater engagement and inclusion far beyond the participants assembled. The consultation clearly demonstrates the enthusiasm of communities and civil society to contribute to the development and implementation of the Plan, and a desire in particular to translate global discussions into country-level activity working on broad health system strengthening efforts towards SDG 3.

We feel it is important that communities, civil society and other non-state actors have sight across the full breadth of the Plan. We would urge a special focus on input from stakeholders in low and middle-income countries as well as representatives from affected populations and marginalized groups.

To this end, we would like to ask the following:

- That, before the release of the final Plan at UNGA in September, a timely, structured process is developed to allow community and civil society feedback at national, regional and global levels.
- 2. That, following the release of the Plan in September, communities and civil society are included in early planning discussions around accountability and implementation of the Plan.

It is our understanding that the Plan is currently scheduled to be finalized over the next six to eight weeks. This is an extremely tight timeframe, which makes the need for adequate consultation with key stakeholders particularly urgent. We are eager to discuss possible solutions, including the possibility of an online consultation. The Global Action Plan Civil Society Advisory Group stands ready to assist in any way which would be useful.

Again, we deeply appreciate your commitment to the Plan, and trust that you will recognize that our communication to you stems from a desire to make it as successful as possible, a call that aligns with your exhortation to come together and work towards realizing SDG3. We intend to raise the issues addressed in this letter during Global Action Plan events at the upcoming World Health Assembly, and suggest that a response from the World Health Organization Director-General, on behalf of the twelve signatory agencies, may be an expeditious way forward.
